The graph shows the derating of current (A) versus temperature (°C) for a VDE 0.34 mm<sup>2</sup> cable. The current is constant at 6.0 A up to 40°C. Above 40°C, the current derates linearly. The derating is more pronounced for the standard VDE cable (blue line) compared to the cable with an additional gasket (red line).
