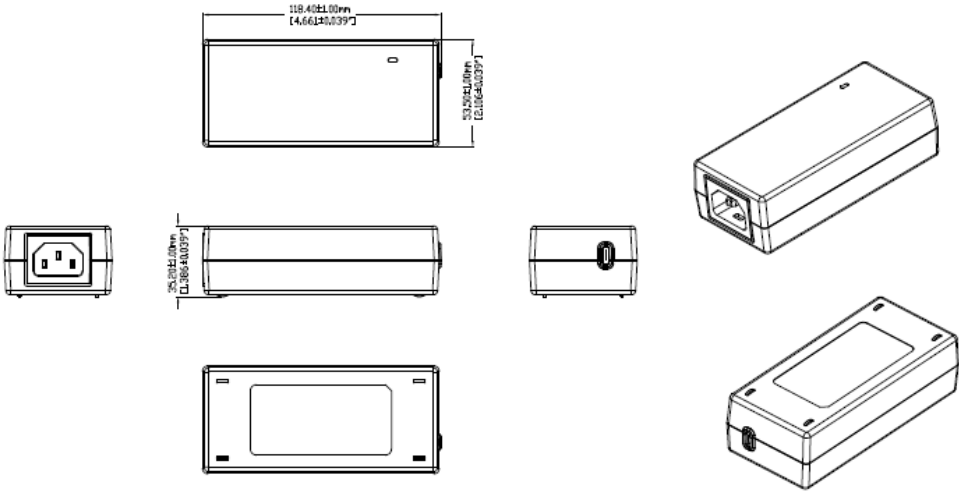

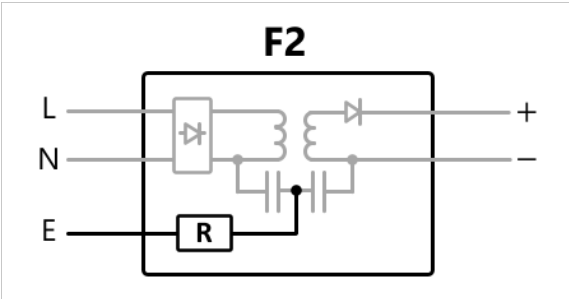
DERATING CURVE

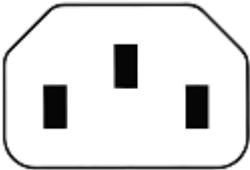
