## **1.0 SCOPE**

This specification specifies the general requirements to describe the packaging procedure for the DIN Valve series C19.

#### 2.0 PURPOSE

The purpose of this specification is to assure that all DIN Valve options shipped from Molex arrive damage free and in a manner which allows ease of handling, storage, and distribution.

## 3.0 GENERAL PACKAGING INFORMATION

The recommended carton closure is tape.

The carton weight should not exceed 15kg.

#### **4.0 PACKAGING OF DIN VALVE OPTIONS**

#### 4.1 OPTION 1 - SINGLE PACKAGED: MOUNTED:

The single pack mounted connector consists of an Insert Assembly and a Cover Assembly mounted together with a screw and gasket where applicable, all placed in a bag (P/N 1211160571).

100 bags of mounted connector assemblies are placed in a carton for shipping, reference Table 1 below for carton part numbers

#### 4.2 OPTION 2 - BULK PACKAGED: MOUNTED:

The bulk pack mounted connector kit consists of 300 Insert Assemblies and Cover Assemblies mounted together and placed in a carton for shipping: reference Table 2 below for carton part numbers.

Where applicable (refer to the Bill of Material), a bag of screws and a bag of gaskets are included.

Components must not be mixed in bags.

This constitutes a kit of 300 mounted connectors.




Figure 3 – Carton Box Dimensions




Figure 4 - Molex Label Example

The labels used are standard Molex Ireland labels and measure 124.0 x 70.0 mm. See Figure 4 below for a label sample.

#### 7.0 SHIPPING PALLETS

#### 7.1 PALLET OPTIONS FOR MULTIPLES OF 500

For orders over 500 and in multiples of 2500 the parts may be put on a pallet.




Figure 5 – Pallet Stacking Layout

The Outer Boxes (P/N 1211160004 and 1211160005) should be stacked on their side's 5 across, inside a pallet box. Reference Figure 5 below for box stacking layout and dimensions.

These should then be fully enclosed in the pallet box as shown in Figure 8 below.

The boxes can then be stacked up to 3 high. This gives a shipping quantity of 2500, 5000 and 7500. For any other quantity, parts must be shipped in boxes of 100 or 500 as specified earlier in this document, or on additional pallets as described above.

Figure 5 below shows how the cartons should be stacked on the pallet.

Note: Pallets should not be stacked on top of one another.

#### 7.2 PALLET OPTIONS FOR MULTIPLES OF 1000

For orders over 1000 and in multiples of 5000 the parts may be put on a pallet.




Figure 6 – Pallet Stacking Layout

The Outer Boxes (P/N 1211160004 and 1211160005) should be stacked on their side's 5 across, inside a pallet box. Reference Figure 6 below for box stacking layout and dimensions.

These should then be fully enclosed in the pallet box as shown in Figure 8 below.

The boxes can then be stacked up to 3 high. This gives a shipping quantity of 5000, 10000 and 15000. For any other quantity, parts must be shipped in boxes of 200 or 1000 as specified earlier in this document, or on additional pallets as described above.

Figure 6 below shows how the cartons should be stacked on the pallet.

Note: Pallets should not be stacked on top of one another.

#### 7.3 PALLET OPTIONS FOR MULTIPLES OF 1500

For orders over 1500 and in multiples of 7500 the parts may be put on a pallet.

The Outer Boxes (P/N 1211160004 and 1211160005) should be stacked on their side's 5 across, inside a pallet box. Reference Figure 7 below for box stacking layout and dimensions.

These should then be fully enclosed in the pallet box as shown in Figure 8 below.

The boxes can then be stacked up to 3 high. This gives a shipping quantity of 7500, 15000 and 22500. For any other quantity, parts must be shipped in boxes of 300 or 1500 as specified earlier in this document, or on additional pallets as described above.

Figure 7 below shows how the cartons should be stacked on the pallet.

Note: Pallets should not be stacked on top of one another.




Figure 5 – Pallet Stacking Layout
