## **IR Receiver Modules for Remote Control Systems**

#### **DESCRIPTION**

This IR receiver series is optimized for short burst remote control systems in different environments. The customer can chose between different IC settings (AGC variants), to find the optimum solution for his application. The higher the AGC, the better noise is suppressed, but the lower the code compatibility.

The devices contain a PIN diode and a preamplifier assembled on a lead frame. The epoxy package contains an IR filter. The demodulated output signal can be directly connected to a microprocessor for decoding. These components have not been qualified to automotive specifications.








Fig. 1 - Output Function








Fig. 5 - Frequency Dependence of Responsivity




Fig. 6 - Sensitivity in Bright Ambient




Fig. 7 - Sensitivity vs. Supply Voltage Disturbances




Fig. 8 - Maximum Envelope Duty Cycle vs. Burstlength




Fig. 9 - Sensitivity vs. Ambient Temperature




Fig. 10 - Relative Spectral Sensitivity vs. Wavelength




Fig. 11 - Directivity




Fig. 12 - Sensitivity vs. Supply Voltage

#### SUITABLE DATA FORMAT

This series is designed to suppress spurious output pulses due to noise or disturbance signals. The devices can distinguish data signals from noise due to differences in frequency, burst length, and envelope duty cycle. The data signal should be close to the device's band-pass center frequency (e.g. 38 kHz) and fulfill the conditions in the table below.

When a data signal is applied to the product in the presence of a disturbance, the sensitivity of the receiver is automatically reduced by the AGC to insure that no spurious pulses are present at the receiver's output.

Some examples which are suppressed are:

- DC light (e.g. from tungsten bulbs sunlight)
- · Continuous signals at any frequency




Fig. 13 - IR Signal from Fluorescent Lamp With Low Modulation




Fig. 14 - IR Signal from Fluorescent Lamp With High Modulation

- Strongly or weakly modulated patterns from fluorescent lamps with electronic ballasts (see Fig. 13 or Fig. 14)



#### **ASSEMBLY INSTRUCTIONS**

#### **Reflow Soldering**

- Reflow soldering must be done within 72 h while stored under a max. temperature of 30 °C, 60 % RH after opening the dry pack envelope
- Set the furnace temperatures for pre-heating and heating in accordance with the reflow temperature profile as shown in the diagram. Exercise extreme care to keep the maximum temperature below 260 °C. The temperature shown in the profile means the temperature at the device surface. Since there is a temperature difference between the component and the circuit board, it should be verified that the temperature of the device is accurately being measured
- Handling after reflow should be done only after the work surface has been cooled off


#### **Manual Soldering**

- Use a soldering iron of 25 W or less. Adjust the temperature of the soldering iron below 300 °C
- Finish soldering within 3 s
- Handle products only after the temperature has cooled off



#### **TAPING VERSION TSOP..TT DIMENSIONS** in millimeters



#### TAPING VERSION TSOP..TR DIMENSIONS in millimeters




#### **REEL DIMENSIONS** in millimeters







#### **DRY PACKING**

The reel is packed in an anti-humidity bag to protect the devices from absorbing moisture during transportation and storage.



#### FINAL PACKING

The sealed reel is packed into a cardboard box.

#### **RECOMMENDED METHOD OF STORAGE**

Dry box storage is recommended as soon as the aluminum bag has been opened to prevent moisture absorption. The following conditions should be observed, if dry boxes are not available:

- Storage temperature 10 °C to 30 °C
- Storage humidity ≤ 60 % RH max.

After more than 72 h under these conditions moisture content will be too high for reflow soldering.


In case of moisture absorption, the devices will recover to the former condition by drying under the following condition:

192 h at 40 °C + 5 °C / - 0 °C and < 5 % RH (dry air / nitrogen) or

96 h at 60 °C + 5 °C and < 5 % RH for all device containers or

24 h at 125 °C + 5 °C not suitable for reel or tubes.

An EIA JEDEC  $^{\!0}\!\!\!\!\!^{^{^{\phantom{0}}}}$  standard J-STD-020 level 4 label is included on all dry bags.

#### **ESD PRECAUTION**
